Part-I Technical Evaluation

1.1 Introduction

The ‘Infrastructure Development Authority of the Punjab’ (IDAP) established by the Government of the Punjab, as an Autonomous body under the Infrastructure Development Authority of Punjab Act, 2016 for planning, designing, construction & execution of Infrastructure in Punjab hereinafter called the Employer, intends to engage competent and qualified Medical Equipment firms for **“Supply, Installation, Commissioning & Maintenance of Laboratory Miscellaneous Package No. 27, Lot-K, Item No. 3: Spectrophotometer, For Tertiary Care Hospital Nishter-II, Multan & Sardar Fateh Muhammad Khan Buzdar Institute Of Cardiology, Dera Ghazi Khan & Establishment of 200 Bedded MCCH & NC at District Mianwali”**

1.2 Bid Process

1.5 Opening & Evaluation of Technical Bids

1.6 Preliminary Examination of Bids

The documents submitted by the bidders were checked in the presence of bidder's representatives.

As per Clause 12.1 of I.T.B of the RFP (Bidding Documents), the bidders were required to furnish bid security equal to an amount of **PKR Twenty Five Thousand Pak Rupees Only**

(Rs.25,000/-) as part of technical bid in the form of Deposit at Call / Pay Order / an unconditional and irrevocable Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favour of Procuring Agency.



