Part-I Technical Evaluation

1.1 Introduction

The 'Infrastructure Development Authority of the Punjab' (IDAP) established by the Government of the Punjab, as an Autonomous body under the Infrastructure Development Authority of Punjab Act, 2016 for planning, designing, construction & execution of Infrastructure in Punjab hereinafter called the Employer, intends to engage competent and qualified Medical Equipment firms for **“SUPPLY, INSTALLATION, COMMISSIONING & MAINTENANCE OF MEDICAL FURNITURE IMPORTED (PACKAGE NO. 09, LOT C, HOSPITAL WARD BEDS) ON DAP BASIS FOR ESTABLISHMENT OF 200 BEDDED MOTHER AND CHILD HOSPITAL AND NURSING COLLEGE, ATTOCK.”**

1.2 Bid Process



1.5 Opening & Evaluation of Technical Bids

The Procurement committee, IDAP opened the Technical Bids of afore-mentioned firms on **04th June,2024 at 15:30 HRS** through E-Procurement Portal in the presence of bidder's representatives who choose to attend. The access of E-Procurement Portal was granted to the evaluation committee members to carry out the evaluation process of technical bids based on the Eligibility and Qualification Criteria as narrated in the RFP (Bidding Document).

1.6 Preliminary Examination of Bids

The documents submitted by the bidders were checked in the presence of bidder's representatives who choose to attend.

As per Clause 12.1 of I.T.B of the RFP (Bidding Documents), the bidders were required to furnish bid security equal to an amount of **Nine Hundred Thousand Pak Rupees Only (Rs.900,000/-)** as part of technical bid in the form of Deposit at Call / Pay Order / an unconditional and irrevocable Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favour of Procuring Agency.




