Part-I Technical Evaluation

1.1 Introduction

The ‘Infrastructure Development Authority of the Punjab’ (IDAP) established by the Government of the Punjab, as an Autonomous body under the Infrastructure Development Authority of Punjab Act, 2016 for planning, designing, construction & execution of Infrastructure in Punjab hereinafter the Employer, intends to engage competent and qualified Medical Equipment firms for **“Supply, Installation, Commissioning & Maintenance of ICU Medical Equipment (Package No. 65), Item No. 14, Echo Machine with TE for Pakistan Kidney & Liver Institute and Research Centre, Lahore.”**

1.2 Bid Process

The process was initiated by IDAP for obtaining the Bidding Documents through advertisement in daily “Express” and “The News” on 18th December, 2019, details attached as **“Annex-A”**. All firms of Medical Equipment vendors were invited to participate in bidding process based on Single Stage – Two Envelope bidding process as per Rule 38(2a) of Punjab Procurement Rules 2014.

In response to the said advertisement, following five (05) firms obtained RFP (Bidding Documents) for ICU Medical Equipment (Package No. 65), Item No. 11, Echo Machine with TE.

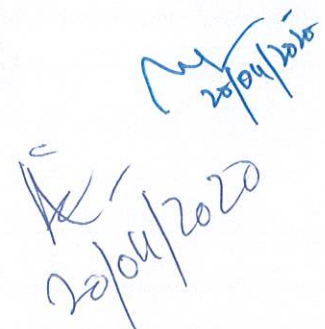

1.3 Bids Submission and Opening

The closing date and time for submission of bids was **January 14, 2020 at 11:00 am**. Following three (03) firms submitted their Technical and Financial proposal against the RFP before the deadline of submission.

2. M/s Mega Plus
3. M/s Medequips SMC (Pvt.) Limited

Technical Proposals were opened on the same day at **11:45 am**.

1.5 Opening & Evaluation of Technical Bids

The Procurement committee, IDAP opened the Technical Bids of three (03) firms on **14th January, 2020 at 11:45 am PST** in the presence of bidder's representatives. The original of Technical Bid was handed over to the Evaluation Committee to carry out the evaluation process based on the Eligibility and Qualification Criteria as narrated in the RFP (Bidding Document).

A bid opening attendance sheet was developed, recorded and attached as **Annex "B"**.

1.6 Preliminary Examination of Bids

The documents submitted by the firm was checked in the presence of bidder's representatives.

As per Clause 12.1 of I.T.B of the RFP (Bidding Documents), the bidders were required to furnish bid security equal to an amount of **Pak Rupees Four Hundred and Fifty Thousand Only (Rs. 450,000/-)** as part of technical bid in the form of Deposit at Call / Pay Order / an unconditional and irrevocable Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favour of Procuring Agency.

M/s Shirazi Trading Company, M/s Mega Plus and M/s Medequips SMC (Pvt.) Limited submitted bid security as part of technical bid and is briefed hereunder:

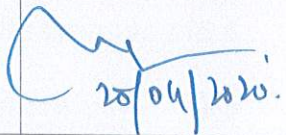
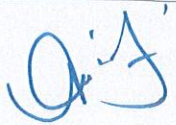
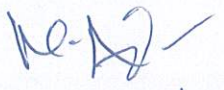
1.8 Evaluation of Technical Bids
