Part-I Technical Evaluation

1.1 Introduction

The 'Infrastructure Development Authority of the Punjab' (IDAP) established by the Government of the Punjab, as an Autonomous body under the Infrastructure Development Authority of Punjab Act, 2016 for planning, designing, construction & execution of Infrastructure in Punjab hereinafter called the Employer, intends to engage competent and qualified firms for "Supply, Installation, Commissioning & Maintenance of Blood Bank Equipment (Package 18, Lot-J-Item 5, Continuous Flow Apheresis System) On DAP Basis for Establishment Of 200 Bedded Mother and Child Hospital and Nursing College, District Attock and Establishment of 200 Bedded Mother and Child Hospital and Nursing College, District Layyah"

1.2 Bid Process


1.7 Preliminary Examination of Bids

The documents submitted by the bidders were checked in the presence of bidder's representatives who choose to attend.

As per Clause 12.1 of I.T.B of the RFP (Bidding Documents), the bidders were required to furnish bid security equal to an amount of **Three Hundred Thousand Pak Rupees Only (Rs. 300,000/-)** as part of technical bid in the form of Deposit at Call / Pay Order / an unconditional and irrevocable Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan in favour of Procuring Agency.




