## **Part-I Technical Evaluation**

### **Introduction**

The ‘Infrastructure Development Authority of the Punjab’ (IDAP) established by the Government of the Punjab, as an Autonomous body under the Infrastructure Development Authority of Punjab Act, 2016 for planning, designing, construction & execution of Infrastructure in Punjab hereinafter called the Employer, intends to engage competent and qualified Medical Equipment firms for “Supply, Installation, Commissioning & Maintenance of Radiology Equipment (Package No. 4 Lot-E) on DAP Basis for Tertiary Care Hospital Nishter II, Multan.”.”

### **Bid Process**

The process was initiated by IDAP for obtaining the Bidding Documents through advertisement in daily “*Nawai Waqt*” and “Express Tribune” on 21<sup>st</sup> July 2021 and 24<sup>th</sup> July 2021 respectively, details attached as “Annex-A”. All firms of Medical Equipment vendors were invited to participate in bidding process (E-Procurement) based on Single Stage – Two Envelope bidding process as per Rule 38(2a) of Punjab Procurement Rules 2014. In response to the said advertisement, following nine (9) firms obtained RFP (Bidding Documents) for Radiology Equipment (Package No.4 Lot-E).


